I hereby Release, Waive, Covenant Not to Sue, and further agree to Indemnify, Defend and Hold Harmless the following parties: New World Track Club, Inc.; USA Track & Field, Inc.; the owners and operators of the facility where the event is contested; their officers, directors, trustees, employees, agents, volunteers officials, coaches and other representatives of any of them (the Released Parties) with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss or expense (including court costs, defense costs and reasonable attorneys fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation (or participation of my minor child) in the Event, including claims for liability caused in whole or in part by the negligent acts or omissions of the any of the Released Parties, including with respect to the provision of information regarding rules and scheduling. I further agree that if, despite this Agreement, I, or anyone on my behalf, makes a claim for Liability against any of the Released Parties, I will indemnify, defend and hold harmless each of the Released Parties from any such Liabilities which may be incurred as the result of such claim.
